## Recreational, Educational, Cultural (REC)

Challenge Aspen's REC division serves any individual at any age living with a cognitive and/or physical disability. This program provides locals, visitors, their families, and peer groups diverse opportunities to experience everything the Roaring Fork Valley has to offer. Over 24 adaptive outdoor activities are offered year-round to build skills and confidence and broaden horizons.

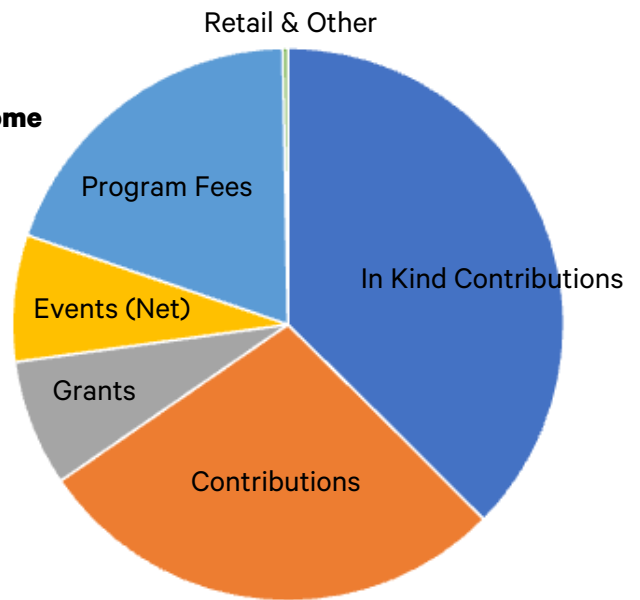

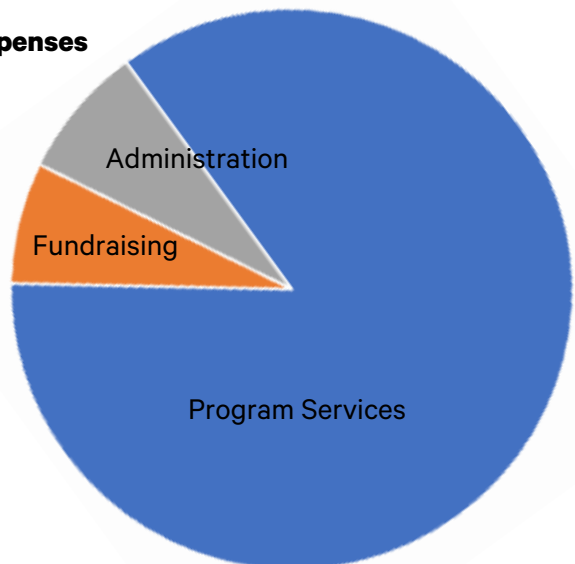
